Debra Kriete E-Rate Qualifications

Debra Kriete has been involved with the E-rate program since Congress enacted the Telecommunications Act of 1996, in February of that year. In the spring of 1996, the Federal Communications Commission convened a joint board made up of federal and state regulators and associated staff, to implement the universal service provisions of the 1996 Act, including the E-rate program. Ms. Kriete served on the staff of the Federal-State Joint Board and worked exclusively on developing the E-rate program rules.

When the final E-rate rules were established in May of 1997, the FCC directed the formation of the non-profit corporation to serve as the E-rate fund administrator. Debra was appointed as the first general counsel of the E-rate administrator, the Schools and Libraries Corporation (now the Schools and Libraries Division of the Universal Service Administrative Company). There, she was responsible for implementing the program rules from November 1997 through mid-1999. She then entered into the private practice of law and returned to Harrisburg, where she performed work for the Fund Administrator on a contract basis, and began advising and counseling E-rate clients.

Since 2004, Debra has worked almost exclusively on E-rate matters, including but not limited to, preparing Forms for filing with the E-rate administrator, preparing and filing successful appeals of E-rate funding denials. Ms. Kriete also serves as a state E-rate coordinator since 2004. She is very knowledgeable, but prudently cautious in assisting applicants particularly in light of the administrator's vigorous enforcement and literal interpretation of program rules due to several well publicized cases of fraud, waste and abuse. At the same time, Debra advocates that each applicant she assists should receive all E-rate funds available within the bounds of the program rules.

Ms. Kriete is licensed to practice law in Pennsylvania and has been a member in good standing of the Pennsylvania bar for 30 years.

CEOT is pleased to submit for your consideration, our proposal to conduct a pre-demolition asbestos building material survey of Rogers Primary School demolition project. If you are in agreement with these terms, please sign this proposal and return.

SCOPE OF WORK #1

CEOT will inspect the site using one Pennsylvania licensed Asbestos Building Inspector and assistant on site conducting a pre-demolition asbestos building material survey. CEOT will review the School's existing AHERA Management Plan. CEOT will schedule a site visit to conduct supplemental and confirmatory sampling of accessible suspect asbestos containing building materials that will be disturbed during the proposed renovations. CEOT will not dismantle equipment/machinery for inspection purposes. CEOT estimates the on site sampling to take a maximum of sixteen (16) hours; additional hours, if necessary will be charged per the attached Additional Rate Schedule.

CEOT will collect and analyze a maximum of one hundred and thirty (130) samples of accessible suspect asbestos containing building materials. The samples will be analyzed using Polarized Light Microscopy with dispersion staining techniques. Patching of interior sampled areas will not be repaired. Limited roof sampling may be conducted at the Owner's request. Roof sample locations will be temporarily repaired. The samples will be analyzed by AGX, Inc. a National Voluntary Laboratory Accreditation Program (NVLAP) accredited laboratory. Additional samples, if necessary, will be charged per the attached Additional Rate Schedule.

CEOT will prepare a report summarizing the findings including the type and location of any asbestos containing building materials observed.

SCOPE OF WORK #2

CEOT proposes to provide the asbestos abatement specifications and drawings for the Rogers Primary School demolition project.

CEOT will prepare the Asbestos Abatement Specifications for the Rogers Primary School project. The specification will include the locations and approximate quantities of the asbestos containing building materials (acbm) to be removed to insure accurate bidding by the abatement contractor. The specifications will also define abatement procedures along with scheduling decided by the Owner, Architect and/or Construction Manager. The Architect will be responsible for advertisement. Along with the written specification, CEOT will produce abatement drawings

Triad Engineering, Inc. (Triad) is pleased to submit this proposal for a geotechnical exploration of the above-referenced site. We have received your Request for Proposal dated October 13, 2015, and Boring Plan dated October 12, 2015. This proposal outlines our understanding of the project, describes our planned scope of work and contains an estimate of the fee (or lump sum as appropriate) for our services.

PROJECT DESCRIPTION

The site for the planned new Rogers Primary School is at the existing school site located at 705 Scott Ave, Glenshaw, Pennsylvania. Based on aerial photography, it appears that the proposed facility footprint is slightly sloping, with some grade changes to the west and south of the proposed facility.

The provided drawing indicates that the development will include a new facility to the south of the existing structure. The existing facility is planned to be completely razed at the end of new construction. A new, two-story building structure is to consist of steel frame construction with concrete block and masonry veneer load bearing walls. The finished floor elevation is was not provided at the time of this proposal. Structural loading information was provided by HHSDR, and we understand that the loads will not exceed 200 kips for columns and seven (7) kips per foot for walls. Associated parking additions and improvements are planned across the project site to accommodate the new facility.

SCOPE OF SERVICES

For the subsurface exploration, we propose to drill 41 test borings with Standard Penetration Testing in soil and rock coring. Upon completion of the field work, we will conduct appropriate soil testing in our laboratory and prepare a detailed geotechnical report. Our planned scope of services is discussed further below.

Field Exploration

We propose to accomplish the test borings with two ATV-mounted rotary auger drill rig and perform Standard Penetration Testing and sampling at 3-foot sample intervals. For the purposes of this proposal, borings TB-1 through TB-31 are estimated to include 20 feet of soil and five (5) feet of rock coring each. Borings SB-1 through SB-10 are estimated to be drilled to depths of 10 feet in soil with no rock coring. Four (4) pavement coring locations (PC-1 through PC-4) are planned within existing asphalt paving. The pavement cores will be drilled using an electric core drill with a 6-inch diamond-bit barrel. Existing asphalt as well as base stone thicknesses will be recorded during asphalt coring. Any planned soil borings, if encountered, within the existing asphalt paving areas will be cored in a manner similar to the PC locations.

A geotechnical engineer representative from our office will be present during the drilling and coring to supervise the field exploration program and log all of the borings. The boreholes will be checked for groundwater upon completion and then backfilled with auger cuttings. We will restore the surface with drill cuttings and/or cold patch asphalt upon completion of the borings. Please note that some settling of this backfill may occur over time. Our proposal does not include return site visits for maintenance of the borehole locations after our on-site work is complete.

Underground Utilities

Unmarked underground utilities pose a grave threat to workers performing subsurface drilling and excavation. Because of this, Triad will contact the appropriate public utility location service (e.g., Miss Utility, One-Call, etc.) to mark underground utilities prior to our subsurface exploration. However, it must be noted that public utility location services will not mark private underground lines or public underground utilities beyond a meter. Therefore, it is your responsibility to disclose the presence and provide the accurate location of all underground utilities not marked by the public utility location service. Triad will not be responsible for any damages that may result from striking underground utilities during the course of the subsurface exploration.

Unless you have specific knowledge regarding on-site utility locations, we recommend that a private utility locator be engaged to provide this service. Triad can provide an additional fee and Change Order to subcontract this service, or you can directly engage a private utility locator. If you choose to be responsible for on-site utility location, please notify our Project Manager and provide satisfactory evidence that the on-site utility location was completed. If evidence of unmarked underground utilities is encountered during our subsurface investigation, Triad will immediately stop work in these areas. You will be responsible for any costs that result from project delays or additional work caused by unmarked on-site utilities.

Laboratory Testing

Laboratory testing will be conducted on representative samples to supplement field classifications, assess potential volume change characteristics and establish foundation and pavement design parameters. The following types and numbers of tests are planned:

Evaluation and Detailed Report

Upon completion of the field investigation and laboratory testing, we will prepare a detailed geotechnical report to adhere to the requested items a through aa of the RFP. The report will include the following items:

- 1) A detailed discussion of the site geology and subsurface conditions encountered.
- 2) Detailed boring logs with a Boring Location Plan.
- 3) Results of laboratory soil testing.
- 4) Potential for expansive shales
- 5) Foundation recommendations with specific references to bearing capacity, settlement potential and seismicity data.
- 6) Recommended modulus of subgrade reaction for design of slabs-on-grade.
- 7) Recommended CBR value for design of flexible pavement based on lab testing.
- 8) Lateral earth pressure recommendations for design of below grade walls or retaining walls.
- 9) Recommendations for site preparation and controlled fill construction.
- 10) Foundation construction procedures.

Our services for this project are strictly limited to those described herein. If necessary, additional services which may be required will be addressed by a change order to this contract.

LUMP SUM FEE AND SCHEDULE

The fee for our services will be based on the unit prices listed herein and the actual quantities of work performed. Based on these unit rates and the scope of work outlined in this proposal, we estimate a total fee of \$43,000. An itemized fee estimate is attached to this proposal.

The quoted unit rates are firm. The quantities of work are estimated based on our past experience and judgment, and therefore, the actual fee for the project may be more or less than estimated. We have estimated a "not to exceed fee" of \$44,000. This includes a contingency to cover unforeseen conditions that may arise during field work and require that additional work be performed while personnel and/or equipment are immediately available. This contingency is designed to protect your interests. If it is necessary to demobilize and later remobilize personnel and equipment, both cost and schedule could be impacted significantly. If we recognize that the Scope of Work required to complete the project will increase significantly (beyond the contingency discussed above), Triad will provide you with a Change Order to authorize additional fees.

The field investigation fees include mobilization and transportation of two drill rigs, and crew to and from the site and the listed totals of soil drilling and sampling. Fees for stand-by time (at the Client's request) or additional soil and rock drilling footage have not been included. The charges for these items will be additional, if required. Charges associated with post-report meetings, plan reviews and extensive consultation have not been included and will be invoiced on a time and materials basis at the prevailing Schedule of Fees rates.

Triad will submit invoices for payment on a monthly basis, or upon project completion, whichever occurs first. Our invoices will be based on the actual amount of work completed in the previous period. Any subcontractor costs will be invoiced immediately upon receipt. Payment is due no more than 30 days following receipt of our invoice unless the provisions of our contract set forth an alternate schedule for payment.

Our work load at the time of authorization will have some influence on the starting date for the investigation. We are normally able to initiate field work within ten working days after written authorization is received. We anticipate that the field exploration will require approximately 6 days (based on two drill rigs), and laboratory testing will require about two (2) weeks. Our report can be submitted within 30 calendar days after completion of the field work. It is emphasized that this schedule is an estimate and it is based on normal work loads and appropriate weather conditions.

This agreement is entered into by Triad Engineering, Inc. (Triad) and HHSDR Architects/Engineers (Client). Client accepts and hereby engages Triad to perform certain professional services as set forth in the Scope of Work of Triad Proposal No. 02-15-0145 dated October 19, 2015, the terms of which are incorporated herein by reference. In consideration for Triad's professional services, Client agrees to be bound by the terms of this Agreement.

1. PAYMENT TERMS: For Clients without prior credit approval by Triad, Client agrees to pay to Triad a retainer of not less than one-half of Triad's estimated project fee prior to Triad beginning work. Payment in full of the remaining balance is due at the time the project is complete, and prior to Triad providing deliverables to Client or as otherwise agreed in writing.

For Clients with credit approval by Triad, payment is due upon receipt of Triad's invoice. However, payment terms are at the discretion of Triad and are contingent upon credit approval, payment history, or other factors considered relevant by Triad. Payment terms may change as factors considered relevant by Triad change. If payment is not received within thirty (30) days from the invoice date, the principal amount of the invoice shall be considered past due. Client agrees to pay a late fee equal to 1.5% per month of the past due principal amount. In the event any amount is past due more than 45 days from the last day services were provided by Triad to the project, Client acknowledges that Triad must take steps necessary to protect its interests by filing such liens as are permitted by law. In the event such undertaking is necessary, Client agrees to reimburse Triad all costs of these activities, including but not limited to attorney fees, court costs and expenses. In the event of non-payment, Client also agrees to compensate Triad for all costs of collection, including but not limited to attorney fees, court costs and expenses, in addition to all late fees accrued as of the date of final collection.

- 2. CHANGES TO SCOPE OF WORK: Client understands and agrees that the fee proposed by Triad to complete the Scope of Work is an estimate based on Triad's understanding of the required Scope of Work at the time the proposal was prepared. In the event Triad discovers that the Scope of Work required to complete the project varies from that originally understood by Triad, Triad will provide to Client a Change Order to authorize the additional services and associated changes to estimated project fees and schedule. Client understands and agrees that it may be necessary and beneficial to Client for Triad to perform additional work beyond that set forth in the original Scope of Work, and that it may be necessary to begin/perform the additional work prior to Client's execution of the Change Order. Client agrees to not unreasonably withhold approval of a necessary Change Order.
- 3. INSURANCE: Triad maintains Workers' Compensation and Employer's Liability Insurance in conformance with applicable state law. In addition, Triad maintains Comprehensive General Liability Insurance and Automobile Liability Insurance with bodily injury and property damage limits of \$2,000,000. A certificate of insurance can be supplied evidencing such coverage which contains a clause providing that fifteen days written notice be given prior to cancellation. The cost of the above coverage is included in Triad's quoted fees. If additional coverage or increased limits of liability are required, Triad will endeavor to obtain the requested additional insurance and Client agrees to pay the costs and premiums associated with additional coverage or increased limits requested by Client.
- 4. STANDARD OF CARE: Triad makes no warranty or guarantee in connection with the services performed hereunder. Triad will use that degree of care and skill ordinarily exercised under similar conditions by reputable members of Triad's profession practicing in the same or similar locality. No warranty, expressed or implied, is made or intended by Triad's proposal for consulting services or by the furnishing of oral or written opinions or reports.
- 5. LIMITATION OF PROFESSIONAL LIABILITY: Client agrees that Triad's liability for any damage on account of any error, omission or other professional negligence will be limited to a sum not to exceed \$50,000 or Triad's fee, whichever is greater. If higher limits of professional liability are desired, Client should discuss the acquisition of additional liability coverage and corresponding charges involved with Triad prior to signing this document. In the event that Client makes a claim against Triad for any alleged error, omission or other act allegedly

arising from Triad's professional service, and the Client fails to prove such a claim, then Client shall pay all attorney fees and other costs incurred by Triad in defending itself against the claim.

- 6. WAIVER OF CONSEQUENTIAL DAMAGES: To the fullest extent permitted by Laws and Regulations, Client and Triad waive against each other, and the other's employees, officers, directors, members, agents, insurers partners, and consultants, any and all claims for or entitlement to special, incidental, indirect, or consequential damages arising out of, resulting from, or in any way related to this Agreement or the Project, from any cause or causes. This mutual waiver includes, but is not limited to, damages related to loss of use, loss of profits, loss of income, loss of reputation, unrealized savings or diminution of property value and shall apply to any cause of action including negligence, strict liability, breach of contract and breach of warranty.
- 7. INDEMNIFICATION: Client agrees to indemnify and hold Triad, its officers, directors and employees harmless against all damages, liabilities or costs, including reasonable attorneys' fees and defense costs, to the extent caused by negligent acts of Client and/or Client's employees, subcontractors or anyone for whom Client is legally liable.
- 8. OWNERSHIP OF DOCUMENTS: All original documents, including, but not limited to drawings, specifications, reports, field notes, calculations and estimates, prepared by Triad as instruments of service pursuant to this Agreement, shall be the sole property of Triad. Client further agrees that under no circumstances shall any documents produced by Triad pursuant to this Agreement be used at any location or for any project not expressly provided for in this Agreement without the written permission of Triad. At the request and expense of Client, Triad will provide Client with copies of documents created in the performance of the work for a period not exceeding five years following submission of the work contemplated by this Agreement. All legal instruments related to boundary surveying, including plats of survey, meets and bounds descriptions, etc., shall be maintained indefinitely.
- 9. DELAYS: In the event that the work is interrupted due to causes beyond the control of Triad, Triad shall be compensated for the labor, equipment and other costs incurred to maintain its work force for Client's benefit during the interruption, or at Client's option, the various costs for demobilization and subsequent remobilization. Compensation to Triad shall be based upon Triad's prevailing fee schedule and expense reimbursement policy. Except for the foregoing provision, neither party shall hold the other responsible for damages or delays in performance caused by acts of God or other circumstances beyond the control of either party which were not reasonably foreseeable. For purposes of this Agreement, acts of God and other circumstances include, but are not necessarily limited to, unusual weather, floods, epidemics, war, riots, strikes, lockouts or other industrial disturbances, protest demonstrations, unanticipated site conditions, or inability despite reasonable diligence to supply personnel, equipment or material to the project. Should such acts occur, Client and Triad shall utilize their best efforts to overcome the resulting difficulties and resume conduct of services called for herein as soon as reasonably possible. Delays within the scope of this provision that cumulatively exceed thirty (30) calendar days shall, at the option of either party, make this Agreement subject to renegotiation or termination.
- 10. RESPONSIBILITIES OF THE CLIENT: Client agrees to provide all information in its possession, custody, or control which relates to the site, its present and prior uses, or to activities at the site which may bear upon the services of Triad under this Agreement, including, but not limited to, the following:
 - a. a legal description of the site, including boundary lines and a site plan;
 - b. historical information as to the prior owners and uses of the site;
 - c. identification of the location of utilities, underground tanks, and other structures and the routing thereof at the site, including available plans of the site;
 - d. a description of activities which were conducted at the site at any time by the Client or by any person or entity which would relate to the services provided by Triad; and
 - e. identification, by name and/or Material Safety Data Sheets, quantity, location, and date, of any releases or handling of regulated and/or toxic/hazardous substances.
- 11. RIGHT-OF-ENTRY: If necessary to complete the Work, Client shall furnish Triad right-of-entry to the project site. Triad will take reasonable precautions to minimize damage to the property caused by Triad operations, by Triad does not include in its fee the cost of restoring damage which may result, unless explicitly stated in the Scope of Work. If Client desires Triad to restore the property to a condition equal to its former condition, such

work shall be specifically stated in the Scope of Work, and costs assigned accordingly. In no case shall Triad be liable for damages caused by others during or subsequent to Triad's operations, including damages arising from trespass facilitated by developing access to the property by Triad.

- 2. DAMAGE TO EXISTING MAN-MADE OBJECTS: It shall be the responsibility of the Client or his duly authorized representative to disclose the presence and accurate location of all hidden or obscure man-made objects at or near test, sample or boring locations. If Triad is provided data in writing as to the presence or potential presence of underground or above ground obstructions, such as utilities, Triad will give special instructions to its field personnel. Client agrees to indemnify and hold Triad harmless from all claims, suits and losses from personal injury, death and property liability damage resulting from unanticipated subsurface conditions, including damage to subsurface structures owned by the Client or third parties, and which occur during, or as a result of, the performance of authorized services by Triad, including but not limited to Triad's legal expenses and costs and any other damage incurred by Triad as a result thereof. If requested by Client in writing, Triad agrees to notify appropriate utility location services in an attempt to identify possible underground utilities at the site prior to the initiation of subsurface exploration activities. The Client, however, retains the responsibility to disclose to Triad the presence and accurate location of any underground utilities or man-made objects which may, or may not, be identified or located at the site by appropriate utility location services, but which are known to exist by the Client.
- 13. SAMPLING OR TESTING LOCATION: Unless otherwise specifically stated in the Scope of Work, Triad's estimated fees do not include costs for determining accurate horizontal and vertical locations of tests, samples or borings. Therefore, locations described in Triad's reports or shown on sketches are based on information furnished by Client or others, or estimates made by Triad's authorized representatives. Such dimensions, depths, or elevations should be considered as approximations unless otherwise stated in writing by Triad.
- 14. UNCONTAMINATED SAMPLE DISPOSAL: Unless otherwise requested, uncontaminated test specimens or samples may be disposed of immediately upon completion of tests. Upon written request, Triad will retain test specimens or samples for a mutually acceptable storage charge and period of time.
- 15. SAFETY: Should Triad provide services at a project site where active construction, manufacturing, or other activity is occurring which could result in health or safety hazards, Client agrees that, in accordance with generally accepted practices, the Client will be solely and completely responsible for safe working conditions on the job site. This includes safety of all persons and property during the performance of the work and compliance with OSHA regulations. These requirements will apply continuously and not be limited to normal working hours. Any monitoring of Client's construction contractor procedures conducted by Triad is not intended to include review of the adequacy of the contractor's safety measures in, on, adjacent to, or near the site.
 - 16. DISCOVERY OF UNANTICIPATED REGULATED AND/OR TOXIC/HAZARDOUS MATERIALS: Triad and Client agree that the discovery of unanticipated regulated and/or toxic/hazardous materials constitutes a changed condition mandating renegotiation of the Scope of Work or termination of services. Triad and Client agree that the discovery of such unanticipated materials will make it necessary for Triad to take immediate measures to protect human health and safety, and/or the environment. Triad agrees to notify Client as soon as practically possible should unanticipated materials or suspected materials be encountered. Client encourages Triad to take any and all measures that in Triad's professional opinion are justified to preserve and protect the health and safety of Triad's personnel and the public, and/or the environment, and Client agrees to compensate Triad for the additional cost of such work. In addition, Client waives any claim against Triad, and agrees to indemnify, defend and hold Triad harmless from any claim or liability for injury or loss arising from Triad's encountering of unanticipated regulated and/or toxic/hazardous materials or such suspected materials. Client further agrees to compensate Triad for any time spent and expenses incurred by Triad in defense of any such claim, with such compensation to be based upon Triad's prevailing fee schedule and expense reimbursement policy. To the extent required by law, Client shall promptly report regulated conditions, including, without limitation, the discovery of releases of regulated and/or toxic/hazardous substances, at the site to the appropriate public authorities in accordance with applicable law.
 - 17. HAZARDOUS OR POTENTIALLY HAZARDOUS SAMPLE DISPOSAL: In the event that samples and/or materials contain or are suspected to contain regulated substances or constituents hazardous or detrimental to health, safety, or the environment as defined by federal, state, or local statutes, regulations, or ordinances, Triad at its sole discretion may, after completion of testing: (1) return such samples and materials to Client, or

- (2) reach an agreement to have such samples and/or materials properly disposed in accordance with applicable laws. Client agrees to pay all costs associated with the storage, transport, and disposal of hazardous or potentially hazardous samples and/or materials. Client recognizes and agrees that Triad is acting as a bailee and at no time assumes title to said waste.
- 18. CONTAMINATED EQUIPMENT: All laboratory and field equipment and/or tools contaminated by unanticipated regulated and/or toxic/hazardous materials as a result of performing the Work will be decontaminated at Client's expense. Contaminated consumables will be disposed of and replaced at Client's expense. Equipment and/or tools which cannot be reasonably decontaminated shall become the property and responsibility of Client. All such equipment and/or tools shall be delivered to Client or disposed of in a manner similar to that indicated for regulated substances or hazardous materials. Client agrees to pay the fair market value of any such equipment and/or tools which cannot reasonably be decontaminated.
- 19. SUBSURFACE RISKS: Whenever engineering or related disciplines are applied to assess subsurface conditions, Client recognizes that special risks occur, and that even a comprehensive sampling and testing program, implemented with the appropriate equipment and experienced personnel under the direction of a trained professional who functions in accordance with a professional standard of care, may fail to detect certain conditions. Therefore, Client assumes the risk that subsurface conditions that Triad properly infers to exist between sampling points may differ significantly from those that actually exist. The passage of time also must be considered, and Client recognizes that, due to natural occurrences or direct or indirect human intervention at the site or distant from it, subsurface conditions may quickly change. Client realizes that nothing can be done to eliminate these risks altogether, but certain techniques can be applied by Triad to help reduce them to that level deemed tolerable by Client. Triad is available to explain these risks and risk reduction methods to Client but, in any event, the scope of services included with this Agreement is that which Client agreed to or selected, in light of his own risk preferences and other considerations.
- 20. CERTIFICATION: Should Triad employ sampling or testing procedures during the course of the work, Client understands that such procedures indicate actual conditions only at the precise locations from which samples or tests were taken, and that Triad will make inferences based on these results to form a professional opinion of conditions in areas beyond those from which samples or tests were taken. Client recognizes that Triad cannot assure the existence of conditions which are inferred to exist from sample or test results. Accordingly, Client agrees that Triad cannot provide any certification of the existence of conditions in locations not directly sampled or tested by Triad.

Unless the Scope of Work specifically provides for certification of the Work beyond those standards set forth in Paragraph 4 of this Agreement, Triad shall not be expected or required to provide any Certification of the Work to Client or third parties. In the event Client anticipates the need for any Certification of the Work by Triad, whether for Client or for third parties, this requirement shall be discussed with Triad's authorized representative prior to execution of this Agreement, and appropriate consideration negotiated.

21. SITE VISITS: Where the Work includes monitoring of project site activities by Triad, Client agrees that the Work does not include site visits at a frequency or number beyond those established in the Scope of Work. It is further agreed that Triad will not assume responsibility for the means, methods, techniques, sequences or procedures of project site activities, and it is understood that services provided by Triad will not relieve others of liability for performing the work in accordance with the plans, specifications, and applicable codes and regulations. Triad will alert Client in a timely manner when Triad deems work pertinent to the Scope of Work is not being performed in accordance with the project plans and specifications. Any deviation from the aforementioned shall be defined in the Scope of Work.

In the event the Scope of Work includes site visits by Triad for any purpose, it shall be Client's or Client's designated representative's responsibility to give Triad reasonable notice of the occurrence of any event or procedure requiring Triad's observation or testing. Triad will not be liable for any aspect of an event or procedure for which Triad does not receive 24 hour notice or such notice as may be otherwise agreed.

22. SUBPOENAS AND OTHER LEGAL NOTICES: All costs associated with compliance with any subpoena for documents, summons, testimony in a court of law, or for any other purpose relating to work performed by Tria under this Agreement, shall be paid by the Client. Costs include, but are not limited to, hourly personnel charges, travel and accommodations, advice of counsel, and all other reasonable associated costs.

- 23. DISPUTES: If a dispute arises out of the performance of this Agreement (including fees due Triad), the parties agree to exercise good faith efforts to resolve the matter fairly, amicably, and in a timely manner. If the dispute cannot be settled through discussion, each party agrees to endeavor to settle the dispute through mediation. The mediation shall be conducted by a mediator authorized by the state bar association in the jurisdiction where the professional services were performed. The parties agree to resort to arbitration, litigation, or other court proceedings, only in the event that mediation efforts fail to resolve the dispute. Regardless of the outcome of the mediation, the costs associated with the mediation, exclusive of attorney fees, expert fees and other costs not related to the actual cost of administering the mediation, shall be borne equally by the parties. Notwithstanding any of the dispute resolution provisions stated herein, Triad may proceed with filing and perfecting by litigation, if necessary, any mechanic's liens otherwise assertable under governing law.
- 24. TERMINATION OF SERVICES: Client or Triad may terminate this Agreement for its convenience upon delivery of three days written notice to the other party. In the event Client requests termination of services prior to completion of the Scope of Work, Client agrees to pay all fees incurred through the date services are terminated, plus any necessary shutdown costs. If during the execution of the services, Triad is required to stop operations as a result of changes in the Scope of Work due to requests by the Client or requirements of third parties, Client agrees to pay Triad such additional reasonable charges as may be necessary to compensate Triad for delay, additional expense, or otherwise, including lost profits.
- 25. AFFIRMATIVE ACTION AND EQUAL EMPLOYMENT OPPORTUNITY: Triad and subconsultant (if applicable) shall abide by the requirements of 41 CFR 60-1.4(a), 60-300.5(a) and 60-741.5(a). These regulations prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities, and prohibit discrimination against all individuals based on their race, color, religion, sex, or national origin. Moreover, these regulations require that covered prime contractors and subcontractors take affirmative action to employ and advance in employment qualified individuals without regard to race, color, religion, sex, national origin, protected veteran status or disability.
- 26. MODIFICATION OF CONTRACT: This Agreement may be modified only in writing, signed by authorized representatives of the Client and Triad.
- 27. GOVERNING LAW: This Agreement shall be governed in all respects by the laws of the State or Commonwealth in which the professional services were performed.

Pursuant to the October 13 written Request for Proposal (RFP) received from Mr. Paul McCullough of HHSDR Architects & Engineers and October 19, 2015 correspondences with Mr. McCullough, Professional Service Industries, Inc. (PSI) is pleased to submit this Revised Proposal to conduct a geotechnical exploration and assessment at the above referenced property. PSI appreciates this opportunity to provide our services for your project. Presented below is a review of furnished project information, along with our proposed scope of services, schedule and fee information.

PROJECT UNDERSTANDING

The following were utilized for preparation of this proposal:

- HHSDR RFP Letter dated October 13, 2015
- HHSDR "Soil Test Boring Plan" drawing TB-1.1 dated October 12, 2015
- HHSDR "Proposed Site Plan" dated September 24, 2015
- October 13, 2015 meeting with Mr. John Carly of HHSDR
- October 19, 2015 correspondences with Mr. Paul McCullough of HHSDR

Based on the aforementioned, PSI understands that the project will consist of demolition of the existing school building structure, construction of a new 2-story school structure, construction of additional paved areas east of the existing and proposed building structures, modifications to the existing paved areas north of the existing building structure, and new paved areas where the existing structure is present. The proposed structure will have overall footprint dimensions of up to approximately 450 feet in length and 185 feet in width. The proposed new parking area will extend approximately 165 feet west from the new building west wall. A segmented block site retaining wall along the western side of the new pavement area may be required and, preliminarily, is anticipated to be up to about 6 feet in height. The specific location and length of this wall have not been provided to PSI at this time.

New building construction will include a steel frame with masonry and brick veneer exterior walls, concrete slabs-on-grade, and concrete retaining walls below grade. PSI has assumed a finished floor elevation at the lower level of EL 1039 feet, NAVD and a finished floor elevation at the upper level of EL 1054 feet, NAVD. Structural loads of up to 200 kips for columns, 7 kips per lineal foot

for walls, and 150 psf for floors are anticipated. Based on the existing grades and assumed lower level finished floor elevation, up to approximately 16 feet of cut is anticipated. For the proposed new pavement area, embankment fill heights of up to approximately 20 feet are anticipated and PSI has assumed new embankment sideslopes will be graded at 2H:1V.

The site of the proposed new building structure consists of open terrain with bituminous concrete, grass, and soil (athletic field) surfaces. Surface topography generally slopes downhill to the south, southeast, and southwest. Existing surface grades within the building footprint area are estimated to range from approximately EL 1054 to EL 1041 feet, NAVD. The area of the proposed new parking lot slopes downhill to the west and southwest with existing slopes estimated to be approximately 4H:1V or flatter. Existing surface grades in this area are estimated to range from approximately EL 1054 to EL 1015 feet, NAVD.

Should any of the above information or assumptions made by PSI be inconsistent with the planned construction, we request that you contact us immediately to allow us to make any necessary modifications to this proposal.

GEOTECHNICAL SCOPE OF SERVICES

Base Scope

The aforementioned RFP and Drawing TB-1.1 indicate that a total of 41 test borings and coring of existing pavement at 4 locations are to be performed. Borings identified on the drawing as TB-1 through TB-31 are to be advanced to depths of at least 20 feet below existing surface grades. Borings identified as SB-1 through SB-10 are to be advanced to depths ranging from approximately 10 to 20 feet. Coring of existing bituminous concrete pavement is to be performed to obtain measurements of existing pavement and aggregate base course thicknesses. Pavement core locations are to be provided by HHSDR at a later date.

For fee estimation purposes, a total of 750 lineal feet of soil drilling and sampling and a total of 155 feet of rock coring (minimum of 5 lineal feet at each boring Borings TB-1 through TB-31 if auger refusal is encountered above the scheduled 20-foot depths) are indicated in the RFP. Undisturbed sampling is to be performed in overburden soil layers where possible at a minimum of 2 borings. Continuous split-spoon sampling of overburden soils is to be performed in the uppermost 6 feet below the design finished floor level or pavement grade at each boring. Final design elevations will be provided to PSI by HHSDR prior to PSI's mobilization and commencement of borings. Below these depths, 5-foot interval sampling is specified. Where existing fill is encountered, interval sampling is to be at 21/2- foot increments.

If auger refusal is not encountered at or above the scheduled termination depths, PSI will not advance the borings to refusal conditions and will not core rock, provided subsurface overburden soils are of sufficient stiffness/density with respect to the anticipated loads. PSI will make adjustments to termination depths based on actual conditions encountered. Should soft soil conditions be encountered which warrant advancing borings below the scheduled depths, PSI will contact HHSDR immediately.



Slope and Site Retaining Wall Stability Analysis

Pursuant to October 19, 2015 correspondences with Mr. McCullough, an additional scope for stability analyses associated with the new embankment fill slope and site retaining wall planned west of the new parking lot is presented. Borings SB-3, SB-4, SB-6, and SB-10 can be repositioned for the purposes of stability analyses. Depending upon actual overburden soil conditions and depths of rock encountered, additional drilling and sampling may be required. For cost estimation purposes, PSI's fee includes 20 lineal feet of additional soil sampling, 20 feet of additional rock coring, and 2 additional undisturbed soil samples. Additional laboratory testing (moisture content, classification, and shear tests on soil as well as unconfined compressive strength of rock) will be performed at PSI's discretion. Fees for additional engineering evaluation are also included. PSI's requests additional planned grading and site retaining wall information prior to performance of these borings.

Boring positions will be located in the field by PSI using scaled drawings provided to PSI by HHSDR, conventional taping procedures, and the existing site features as references. Ground surface elevations will be determined based on interpolation of surface contour interval lines presented on the aforementioned drawings provided to PSI by HHSDR.

IBC SCOPE EVALUATION

The project site is located within a municipality that employs the International Building Code (IBC), 2009 edition. As part of this code, the design of structures must consider dynamic forces resulting from seismic events. These forces are dependent upon the magnitude of the earthquake event as well as the properties of the soils that underlie the site.

Part of the IBC code procedure to evaluate seismic forces requires the evaluation of the Seismic Site Class, which categorizes the site based upon the characteristics of the subsurface profile within the upper 100 feet of the ground surface.

To define the Seismic Site Class for this project, and in accordance with your requested level of assessment, we propose to interpret the results of our soil test borings drilled within the project site and estimate appropriate soil properties below the base of the borings to a depth of 100 feet, as permitted by the code. The estimated soil properties will be based upon data available in published geologic reports as well as our experience with subsurface conditions in the general site area.

Additionally, we propose to calculate the applicable site coefficients F_a and F_v , based upon short period and 1.0 second period accelerations obtained for the site location as presented on the maps in the building code or by accessing the USGS database.

For structures where the Seismic Design Category is interpreted to be Category C, D, E or F, the code requires an assessment of slope stability, liquefaction potential, and surface rupture due to faulting or lateral spreading. For certain types of buildings and sites, an evaluation of seismic stresses on retaining and basement walls (if planned) may also be required. Detailed evaluations of these factors are beyond the scope of this proposal.



SITE ACCESS

PSI anticipates drilling on-site on weekdays during the hours between 7:00 AM and 5:00 PM EST. If an alternate drilling schedule is required, PSI should be notified prior to mobilization or additional fees will apply.

LABORATORY TESTS

Representative soil samples obtained during the field exploration program will be transported to the laboratory for classification and to perform a limited number of engineering properties tests. The nature and extent of this laboratory testing program will be dependent upon the subsurface conditions encountered during the field exploration program.

Representative soil samples obtained during the field exploration program will be transported to the laboratory for classification and to perform a limited number of engineering properties tests. The nature and extent of this laboratory testing program will be dependent upon the subsurface conditions encountered during the field exploration program. PSI proposes a program which may include testing of selected samples to evaluate the moisture content, particle size distribution, plasticity, moisture-density, unit weight, compressive strength, shear strength, and bearing ratio characteristics of existing soils. Unconfined compressive strength testing will be performed on select rock samples. If rock is encountered that is suspected of being potentially expansive (such as carbonaceous shale), samples will be tested for total forms of sulfur to evaluate potentially expansive characteristics.

Specific laboratory testing for this project will be determined once we have completed the field exploration phase of work, as well as the visual logging and classification of the samples obtained.

FIELD EXPLORATION SUPERVISION

PSI representatives will supervise all of the fieldwork exploration activities for this project under the direction of a PSI geotechnical project manager and a licensed engineer in the Commonwealth of Pennsylvania.

EXCLUSIONS

Detailed surface and subsurface water flow (hydrologic) studies and retaining wall designs are not included in PSI's scope. PSI will provide geotechnical recommendations shallow groundwater control associated with the proposed structures and site grading as actual encountered conditions warrant.

Project services proposed herein are conventional in nature and do not include an evaluation of the site for determining the presence or absence of wetlands or hazardous or toxic materials. Nor do these services lessen the risk of conditions that can contribute to moisture, mold or other microbial contaminant amplification in buildings. Please be aware that mold is abundant in nature and is comprised of a wide variety of microscopic fungi. Due to its nature, the potential for mold cannot be completely eliminated.



PSI offers a wide array of services for professional environmental assessments, moisture, waterproofing, indoor air quality and mold determinations which help reduce the likelihood of future occurrences. We are interested in discussing these service options with our clients to suit their specific project needs. These issues, identified in the preceding paragraph may only be addressed under a separate proposal and authorization.

REPORT

Upon conclusion of our field exploration and laboratory work, the data will be analyzed by our experienced geotechnical engineers and a report will be prepared. The report will include the following:

- > Geologic review of the project site.
- > Subsurface conditions encountered including pertinent soil properties
- > Soil or rock data review/analysis as it relates to the proposed site development
- Geotechnical recommendations for site preparation and placement and compaction of fill.
- > Geotechnical recommendations to support building foundations, slabs-on-grade, below-grade building walls, site retaining walls, and pavements.
- > Comments relating to observed geotechnical conditions such as shallow refusal material or groundwater which could impact development.
- > Analyses and geotechnical recommendations associated with the planned slope regrading, embankment fill slopes, and site retaining wall.

This proposal is based on providing one signed electronic and ten bound hard copies and one loose hard copy of the report signed and sealed by a Professional Engineer licensed in the Commonwealth of Pennsylvania. The report will be addressed to the client, and hard copies submitted to client by regular mail. If additional copies of reports are needed from PSI an additional fee of \$35 per copy will be charged.

SCHEDULE

Based upon our current schedule, PSI proposes to initiate services on this project within 10 working days after receiving authorization to proceed. Assuming favorable weather conditions and an anticipated 10 to 11 days for field activities, PSI proposes to deliver the report within 30 days of completion of drilling.

SPECIAL INSTRUCTIONS

Your communication of site development plans and other such documents to us is needed. Upon project start-up, PSI will contact you or your designated representative regarding this information and project scheduling.

Some damage to the ground surface may result from the drilling operations near the work areas and along ingress/egress pathways. We will attempt to limit such damage, but no restoration other than backfilling at the test boring locations is included.



PSI will contact the Pennsylvania One Call System (POCS) for public utility clearance prior to the start of drilling activities. Please note that this service does not mark the locations of privately owned utilities. The presence of private utilities existing near proposed borings that are not identified and marked pose a significant health and safety threat if encountered during drilling activities. We request that <u>all</u> private utility lines and other subsurface appurtenances be located in the field by others prior to our mobilization. Otherwise, PSI can subcontract a private utility locating company for an additional fee of \$250 per hour, if requested.

PROPOSED FEES

PSI proposes that the fee for performance of the outlined scope of services be determined on a unit rate basis in accordance with the attached Schedule of Geotechnical Services and Fees. For the based scope of work presented above, we estimate the fee at \$28,295.00. PSI's proposed fee for west slope and site wall stability analyses is estimated at \$4,855.00 for a total estimated fee of \$33,180. Detailed estimates are attached.

Field exploration services such as drilling and subsurface logging are a vital data gathering element of our services for this project. These require substantial commitment of PSI resources, consumables and other expenses in the beginning of your project, to be able to conduct laboratory testing engineering analysis and report development for your project. Please note, therefore, that we will invoice you partially for the field exploration portion of our work upon its completion, with the balance of our fee invoiced in a manner consistent with terms and conditions described herein. Your acceptance of this proposal acknowledges your approval of this procedure.

Boring, sampling and testing requirements are a function of the subsurface conditions encountered. This estimated fee assumes that adequate bearing materials will be encountered within the proposed boring depths. Following our telephone discussion of October 14, 2015, GeoMechanics, Inc. is pleased to present its cost estimate for performing a subsurface exploration and geotechnical engineering investigation for the proposed Primary School. This cost estimate is based on the following:

- 1. visit to the site to observe physical setting and equipment accessibility
- 2. review of available geologic and mining data
- 3. project information and scope provided by HHSDR

The purpose of this investigation is to determine and characterize the subsurface geomaterial at the proposed building location site, retaining walls, critical cut and fill areas and parking lots by conducting a number of geotechnical borings. Evaluation of data collected from literature search and geologic reconnaissance of the site combined with the data collected from the test borings and laboratory testing program with respect to the design and construction of the building foundations, slopes and retaining walls as well as pavement are the objectives of this study.

In order to achieve the above objectives GeoMechanics, Inc. will perform the following

- 1. Subsurface Exploration
- 2. Laboratory Soil Testing
- 3. Engineering Analysis and Report

Each one of the above tasks is discussed below:

October 19, 2015

1. Subsurface Exploration

This task forms the first phase of data collection and material characterization and consists of drilling a total of thirty-five (35) test borings, twenty-one (21) borings (TB-1 through TB-21) within the school building footprint, nine (9) borings (W-1 through W-9) along the anticipated retaining wall and slope, five (5) borings (P-1 through P-5) in the area of the existing parking lot. The number of borings in the building are dictated by the building footprint; the borings along the wall are based on the anticipated length of wall and the slope below the wall, the data from which will be used for both design of wall and global stability of the overall slope. The pavement borings are located at a reasonable spacing across the paved area. For boring locations, see the attached Test Boring Plan.

The depths of the borings at the building are dictated by the anticipated column and wall loads, estimated thickness of soil zone, existing ground surface elevations as well as the proposed ground floor slab elevations. Unless the subsurface conditions are extremely poor, the building is most likely to be supported by shallow foundations with or without some ground improvement. Therefore, the borings are proposed to extend about 20 feet below the bottom of footing. This depth is considered the area of major stresses imposed by shallow foundation. For boring depths, see the attached Test Boring Schedule. A review of geologic mining literature indicated the project site lies below the Pittsburgh coal horizon. Therefore, there is no risk of mine subsidence and, consequently, no need to drill deep borings extending to the mine. The wall borings are designed to sample 10 feet of rock so that representative slope stability models can be developed. Pavement borings will be terminated after obtaining the pavement cores and 5 feet of subgrade.

The overall purpose of the above borings is to determine the type, thickness and engineering characteristics of soils; lithology and geomechanical properties of rock and to assess local ground water condition.

2. Laboratory Soil Testing

This task forms the second phase of data collection and material characterization and will include index properties tests, compaction tests, shear strength tests and CBR tests. Index properties include moisture content, gradation (sieve and hydrometer) and plasticity (liquid and plastic limits). The data from these tests in conjunction with SPT N-values obtained from test borings will be used to select soil parameters needed for calculating bearing capacity, settlement, lateral earth pressure, slope stability. The values obtained from the compaction test and CBR tests will be used for the fill placement and pavement design. No pyritic material is expected to be present at the site.

October 19, 2015

Engineering analysis and Report

This task involves interpretation, correlation and presentation of field and laboratory data collected on geologic cross sections. Performance of bearing capacity, settlement, lateral earth pressure for the building and retaining structures and pavement analyses and preparation of a report that will document all the data collected, analyses performed and a set of recommendations for the following aspects will also be part of this task:

- 1. foundation support system(s) for the school building;
- 2. type and foundation support of the retaining walls;
- 3. geotechnical design parameters such as allowable bearing capacity, permissible settlement, coefficients of lateral earth pressure, California Bearing Ratio (CBR), modulus of subgrade reaction and seismic coefficient;
- 4. pavement design;
- 5. general earthwork construction criteria, material utilization, placement and compaction, etc.; and

AGREEMENT

THIS AGREEMENT, made this 21st day of October 2015, between the Shaler Area School District, a public school district organized pursuant to the laws of the Commonwealth of Pennsylvania, with its administrative offices at 1800 Mt. Royal Boulevard, Glenshaw, PA 15116, hereinafter referenced as "SCHOOL," and GeoMechanics, Inc., a Pennsylvania corporation having its principal place of business at Millennium III Professional Park, 600 Munir Drive, P.O. Box 386, Elizabeth, Pennsylvania 15037, hereinafter referenced as "CONSULTANT."

WHEREAS, SCHOOL DISTRICT desires to engage CONSULTANT, and CONSULTANT has agreed, to provide subsurface exploration and geotechnical engineering investigation services in furtherance of the construction of a new Rogers Primary School in accordance with the terms and conditions hereinafter provided;

NOW THEREFORE, in consideration of the mutual covenants expressed herein and intending to be legally bound hereby, the parties agree as follows:

- 1. SCOPE OF WORK: SCHOOL hereby engages CONSULTANT as an independent contractor for the provision of subsurface exploration and geotechnical engineering investigation services as more fully described in CONSULTANT's proposal dated October 19, 2015, appended hereto as Exhibit "A" and incorporated herein as part of this Agreement. CONSULTANT's services shall be performed as expeditiously as is consistent with professional skill and care and so as not to delay the progress of construction of the project.
- 2. **PAYMENT**: CONSULTANT shall invoice SCHOOL based upon the actual number of hours expended and testing performed in an amount not to exceed the fee estimate set forth in CONSULTANT's proposal dated October 19, 2015. Invoices shall be submitted no more frequently than each calendar month. Payment of CONSULTANT's fee shall be made within forty-five (45) days after receipt of CONSULTANT's invoice.
- 3. **COMPLIANCE WITH LAWS AND POLICIES**: CONSULTANT shall fully obey and comply with all laws, ordinances, resolutions and administrative regulations, including SCHOOL policies, which are or should be applicable to any work performed under this Agreement.
- 4. **INSURANCE**: CONSULTANT will maintain automobile, general, liability, professional liability, umbrella liability and workers compensation insurance covering all operations, locations, vehicles and employees used in the performance of this Agreement. The CONSULTANT's insurance shall provide, at minimum, the following coverage:

Primary Automobile Liability \$ 500,000

General Liability \$1,000,000

Professional Liability \$1,000,000

Umbrella Liability \$1,000,000

Workers Compensation at Statutory Limits

A certificate of insurance in favor of the SCHOOL must be provided. The general and umbrella liability policies shall designate the SCHOOL as an additional insured, and as such, provide coverage to the SCHOOL on a primary basis and applied without contribution by the SCHOOL or before any other insurance carried by the SCHOOL. The policies must further provide that the policies shall not be cancelled, non-renewed, or materially changed so as to affect the insurance described until thirty days notice of such action has been delivered to the SCHOOL.

- 5. **INDEMNIFICATION**: CONSULTANT shall indemnify, defend and hold harmless the SCHOOL from and against any and all damages, costs, including attorneys' fees, judgments, settlements, claims or expenses of any nature arising out of its performance under this Agreement. To the fullest extent permitted by law, CONSULTANT, for itself and for its subcontractors and suppliers and their respective agent, employees and servants, expressly waives any and all immunity or damage limitation provisions available to any agent, employee or servant under any workers compensation acts, disability benefit acts or other employee benefit acts, to the extent such statutory or case law would otherwise limit the amount recoverable by the SCHOOL pursuant to this indemnity provision.
- 6. **ASSIGNMENT / SUBCONTRACTING**: CONSULTANT shall not subcontract or assign any of the services covered by this Agreement or any right to monies to be paid hereunder without the written consent of SCHOOL.
- 7. **CONSTRUCTION**: This Agreement has been jointly drafted by the parties hereto, each having the benefit of representation of counsel of their own choosing. Accordingly, the provisions of this Agreement shall not be presumptively construed in favor of or against any party hereto. The terms and conditions of and obligations created by this Agreement shall be governed by and construed pursuant to the laws of the Commonwealth of Pennsylvania.
- 9. **ENTIRE AGREEMENT**: This Agreement constitutes the full and integrated agreement between the parties relative to the subject matters hereof. In entering into this Agreement, no party is relying upon any prior or contemporaneous oral or written representations, promises, negotiations, covenants or other understandings of any kind. This Agreement may not be changed, modified, discharged or extended except by written amendment, duly executed by the parties and, with respect to the SCHOOL, unless approved by action of its Joint Operating Committee at a duly constituted public meeting.

10. **DISPUTE RESOLUTION**:

(A) All claims, disputes and other matters in question between the CONSULTANT and the SCHOOL arising out of, or relating to, this Agreement or the breach thereof shall, at the SCHOOL's sole and exclusive option, be decided by arbitration in accordance with the Construction Industry Arbitration Rules of the American Arbitration Association then in effect. The SCHOOL's election to arbitrate shall be specifically enforceable under the prevailing arbitration law. The award rendered by the arbitrators shall be final, and judgment may be entered upon it in accordance with applicable law in any court having jurisdiction thereof. Nothing contained in this Article is intended or shall be construed to entitle the CONSULTANT to demand arbitration, it being understood and agreed that such determination shall be at the sole discretion of the SCHOOL. The SCHOOL's election to proceed in arbitration shall be exercised within sixty (60) days following either a request by the CONSULTANT for arbitration or service of original process upon Owner pursuant to a civil proceeding. In the event the SCHOOL does not affirmatively elect to proceed in arbitration within sixty (60) days, the CONSULTANT may proceed with a civil proceeding. CONSULTANT shall commence an

arbitration or civil proceeding as elected by the SCHOOL not later than thirty (30) days following the SCHOOL's election or any such claims shall be waived and barred.

- (B) The venue of any arbitration or court proceedings arising from this Agreement shall be the Court of Common Pleas of Allegheny County, Pennsylvania.
- (C) In the event any dispute is litigated through civil proceedings in a court of law or equity, the CONSULTANT waives the right to a trial by jury.
- (D) In the event any dispute is litigated through arbitration as provided above, the CONSULTANT consents to its joinder in or consolidation of such arbitration with any other arbitration proceeding to which SCHOOL is a party as may be necessary for a full adjudication of the dispute.
