The purpose of this agreement is to establish procedures and agreed upon processes between Shaler Area School District and CYF to ensure the provision of services to optimize academic success for children and youth in foster care who are enrolled in the LEA.
- C.7 Approval of the transportation procedures established with the Allegheny County Department of Human Services, Office of Children, Youth and Families (CYF). Based on this school placement decision, the LEA will work collaboratively with CYF and placement agencies to identify and establish the most cost-effective method of transport.
- C.8 Approve the property damage release with R&B Contracting and Excavation sustained during the Primary School Construction. The total payment recovery will be \$11,179.05 which is the cost of the repairs.
